

Preliminary Operating Statistics

For the 4th Quarter 2018 & Full Financial Year Ended 2018

PT AirAsia Indonesia Tbk ("the Company") is pleased to announce the operating statistics for the 4th Quarter of the Financial Year 2018 ("4Q18") and the full financial year ended 31 Dec 2018 ("FY2018").

During the 4th Quarter, the eight aircraft previously operated by Indonesia AirAsia Extra ("IAAX") have been fully transferred back to Indonesia AirAsia ("IAA"), resulting in the Company's higher than normal 4Q18 numbers. The Company recorded a 56% increase in passengers carried on the back of 50% added capacity, while load was up by 3 percentage points ("ppts") to 82% as compared to the same quarter last year.

For the full year of 2018, The Company carried a total of 5.2 million passengers, up by 13% year-on-year while load was down by 2 ppts to 82% on the back of 16% added capacity, as well as a less optimistic operating environment as a whole due to the prolonged chain of natural disasters throughout the year. The Company took in one aircraft and eight transferred aircraft closing the year with a fleet of 24.
